NOW THIS DEED OF TRUST WITNESSTH AS FOLLOWS -

ONE ::

(a) The name of the Trust shall be "AL NOOR-UL HIDHAYA EDUCATION TRUST".

(b) The Office of the Trust shall be situated at Sominakoppa, Vinobanagar Post, Shimoga, Karnataka State. The Trustees with the consent of majority of the Trustees are authorised to change the office of the Trust as and when they find it necessary and also are authorised to establish as many Branch Offices at such places and for such purposes as they may find it necessary for the efficient management of the Trust.

TWO ::

A. The aims and objectives of the Trust shall be :-

(1) Advancement and propagation of Education and learning including establishment, maintenance and support of Schools, Colleges, Residential Institutions, under the State and CBSE and ICSE Syllabus in Kannada, Urdu and English Medium, Training Centres and other Educational Institutions.

(2) To make provision to advance the cause of, and impart Pre-primary, Primary, Secondary, Higher, Commercial, Industrial, Technical, Physical, Professional, Medical, T.C.F. Colleges, D.Ed. and B.Ed. Colleges, Nursing Schools, Fashion Designing Course; and all or any other type or kind of education.

(5) To hold arrange and organise Meetings, Lectures, Talks, Discussions, Seminars, Symposia, Conferences, Competitions, Research and Study Visits, Tours, Trekking, Excursions, Exhibitions, Debates, Cinema, Audio-Visual programmes, Artistic performances and other cultural activities, Sports and Games and to form and float Foundations to do any or all such programmes, activities and performances.

(6) Establishment, maintenance and support of Libraries, Museums and Reading Rooms and Distribution of Books, etc., for the advancement of education and knowledge in general.

(1) To collect funds by way of subscriptions, contributions, fees, charities, donations, grants, subsidies, loans, deposits, etc., from trustees, the general public, banks, govt. state/central, other govt./non govt. organisations (NGO's) and bodies corporate including foreign agencies and organisations.

(2) To acquire and hold, sell, mortgage, dispose of, or otherwise to deal with all or any of the properties of the Trust, by way of purchase, hire, Lease, etc.,

(3) To establish or acquire, promote, run and maintain educational and spiritual institutions, hospitals, organisations of all kind in such places as may be decided upon, by a majority of the Trustees. The said Institutions shall be open to people of all communities, caste and religion.

(4) To collaborate and join hands with similar institutions towards realization of objectives of the Trust.

(5) To sell, lease, license, mortgage, exchange, gift, alienate, dispose off, manage, develop, improve or any of the properties or assets of the Trust as may be thought fit for, with a view to promote the objects of the Trust.

(6) To take up such other objectives not inconsistent with the spirit of the Trust and the objects that the trustees may add to the above mentioned objects, having regard to the particular needs of the time and not inconsistent with the provisions of Income Tax Act, 1961

(7) To invest the funds of the Trust, which are not required immediately for activities of the Trust in any of the modes specified under the provisions of the Sec. 13(1)(d) read with Sec. 11(5) of Income Tax Act, 1961 as amended from time to time.

THREE :-

The Trust property shall mean and include the said sum of Rs. 500=00 (Rupees Five Hundred Only) and any further grants, donations and contributions of money and/or property movable and immovable that may be made by the Trustees or by others from time to time and other accumulations, and accretions thereof in whatever form they may be varied from time to time.

SIX :-

The Trust es are wholly indemnified against any expenses or losses incurred or suffered in regard to any act, deed or omission thereof in the performance of their duties as trustees or any payment made by them in good faith in the administration of the trust and such expenses, losses and payments shall be borne by the trust and none of the trustees shall in any way be personally liable or responsible for the same.

INVESTMENT :-

The funds of the trust shall be invested in the manner and the modes specified under the provisions of Sections 13(1)(d) read with Section 11(5) of the Income-Tax Act, 1961, as amended from time to time.

THIRTEEN :-

In the event of dissolution or winding up of the trust, the net assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another Charitable Institution, whose objects are similar to those of the trust and which enjoys recognition under Sec. 80 G of the Income Tax Act, 1961 as amended from time to time.

FOURTEEN :-

The trust may acquire any movable or immovable property for the purpose of achieving the objects of the trust as long as they do not violate the instruction placed on the investment under the Income-Tax Act. The Trustees are free to realise, sell, change the investments from one category to another.

FIFTEEN :-

The trustees are free to effect amendments to this deed of trust without, however, affecting the objects for which this trust is established, also no amendments shall be made to the trust deed which may prove to be repugnant to the provisions of Sections 2(15), 11, 12, 13 and 80 G of the Income Tax Act, 1961 as amended from time to time. However, no amendments shall be carried out without the prior approval of the Commissioner of Income Tax, if the certificate under Section 80 G is obtained

SEVENTEEN :-
